

IN THE SUPREME COURT OF MARYLAND
ORDER REVISING END DATE OF TERMS OF
CERTIFICATION OF RECALLED SENIOR JUDGES

Whereas, on December 14, 2022 the Supreme Court issued an Order Approving Revised Process for Application for Certification of Former Judges for Recall. Among other things, that order established a uniform process for the recertification of senior judges for recall at the same time each year, including the establishment of a date of June 30 for the expiration of all terms of certification and recertification; and

Whereas, to accomplish the goal of implementing that uniform process immediately, the Supreme Court will adjust the end date of current certification and recertification terms of senior judges for recall to end on the June 30 immediately following the current end date of the existing term,

Now, therefore, it is ordered, by the Supreme Court of Maryland, this 14th day of December 2022, that the current term for which the following senior judges have been certified or recertified for recall pursuant to § 1-302 of the Courts and Judicial Proceedings Article is extended through June 30, 2023, with applications for recertification due no later than April 15, 2023:
