3. **Filing Procedure** – Create your Character Questionnaire in eBar, submit it online, then print a hard copy using the printer icon on your “My Status” page, file the hard copy with your ****official undergraduate (college) transcript(s)**** and Character Questionnaire fees. Contemporaneously or after filing your Character Questionnaire, create and submit online your Notice of Intent to Take the UBE in Maryland OR your Notice of Intent to Transfer a Qualifying UBE Score to Maryland; print, sign and file a hard copy of the Notice of Intent with the appropriate fee.
