Day of Trial Alternative Dispute Resolution (ADR) Programs

Day of Trial ADR services are offered in-person on the trial date at the court location where the trial is scheduled. In the courtroom, cases may be referred to ADR by the judge, or the parties may request ADR services. An ADR Practitioner must be scheduled and appear to provide ADR, and all parties in the case must be present for the case to be referred to ADR. The ADR process will take place in a private room in the courthouse. If the case is not resolved in ADR, the parties will return to the courtroom for the scheduled court process.
