- 2. Select the Log in link to take you to the Attorney Information System.
- 3. Log into AIS.
 - a. Enter your **Email** as the AIS Login ID. Select **Next**.

NOTES: Related to the Issue Date field on the forms:

Print a copy of the completed form

The <u>Issue Date field</u> on the form populates the current date each time the form is opened, even on forms that have been completed and saved to your computer. For that reason, you may want to print a copy of a completed form for your records.

If the current date is not showing on the form:

Some browsers have built-in pdf viewers that may not populate the current date in the <u>Issue Date</u> <u>field</u>. If this occurs, you can change the settings in your browser to view .pdf files with Adobe Acrobat or Reader or you can download the form to your computer and open with Adobe Acrobat or Reader. The current date should appear in the <u>Issue Date field</u>.

- 9. Enter the information needed into the form.
 - a. Forms can be saved and printed.
 - b. If the wrong information was entered the form can be reset and all data entered will be cleared from the form.

NOTE: Form Revision dates will be noted in AIS next to each form as updated in AIS.
