HCM Systems > Self Service > Leave Transfer Requests > Enroll into Leave Bank

Once you have enrolled, you will be able to view your Leave Bank at the following path in CONNECT:

Main Menu > HCM System > Self Service > Leave Transfer Request > Leave Transfer Request History

NOTE: Supervisors/Managers do not approve the <u>enrollment</u> into the Leave Bank. Therefore, they will not receive an approval notification for <u>enrollment</u>. They will, however, be involved in the process when an employee <u>requests</u> the use of Leave Bank.
