

It may take a few weeks before a trial/waiver hearing date is set. The court will mail a courtesy notice to the name and address shown on the front of the citation. If your name or address on this citation is not correct you must notify the court in writing of any changes. The Post Office does not forward court mail. IF CITATION IS MARKED "YOU MUST APPEAR FOR TRIAL"

This citation is a summons to appear. The court will automatically mail you a notice of your trial date. Please read "Important Information" above. You must appear in court as directed.

- A lawyer can be helpful to you by:
  - explaining the charges in this paper; (A)
  - (B) (C) telling you the possible penalties; explaining any potential collateral consequences of a conviction, including immigration

  - helping you at trial;
  - (D) (E) helping you protect your constitutional rights; and

(E) helping you protect your constitutional ngnts; and
 (F) helping you to get a fair penalty if convicted.
 6. Even if you plan to plead guilty, a lawyer can be helpful.

If you are eligible, the Public Defender or a court-appointed attorney will represent you at any initial appearance before a judicial officer and at any proceeding under Rule 4-216.2 to review an order of a District Court commissioner regarding pretrial release. If you want a lawyer for any further proceeding, including trial, but do not have the money to hire one, the Public Defender may provide a lawyer for you. To apply for Public Defender representation, contact a District Court commissioner.
