- 1. In Court Proceedings when a court reporter is present, the official record will be the transcript prepared by the court reporter. Pursuant to the unreported opinion CSA-ALA-2382-2017 *Romero Rolando Ortuno v. State of Maryland*, and Rule 16-504, audio of proceedings are available upon written request and payment of reasonable costs of making the copy.
- 2. In Court Proceedings when a court reporter is not present, the official record will be the audio recording. Pursuant to Rule 16-504, CD will be available for purchase, except as provided in Rule 16-504(h).
- 3. In Magistrate's Proceedings, the official record will be the audio recording. Pursuant to Rule 16-504, a CD will be available for purchase, except as provided in Rule 16-504(h).
- 4. If a CD is purchased, it may be used for reference only. It may not be used in Court in place of a transcript. The CD may not be duplicated or used except as provided for in Rule 16-504.

- 5. Because of the regulations governing transcript preparation, you must order a transcript through the Office of the Court Reporters. The CD cannot be used to prepare a transcript.
- Each hearing date will be recorded on a separate CD. The fee is \$25.00 for each CD. Make your check or money order payable to: Worcester County, Maryland, 1 West Market Street, Room 228, Snow Hill, Maryland, Attention: Kathy Zeve.
- 7. The previous Policy (Procedures for Obtaining Official Court Recording) dated May 29, 2013 is hereby rescinded.
