ORDER

The Administrative Office of the Courts has certified to the Clerk of this Court that the attorneys listed in the attachment to this order are in default of duties imposed by one or more of the following Rules: Rule 19-409 (duty to file an IOLTA Report), Rule 19-503 (duty to file a pro bono legal service report), Rule 19-605 (duty to pay an annual assessment as invoiced and provide information regarding a social security number (SSN) or federal Tax Identification Number (TIN)). Pursuant to Maryland Rules 19-409(c), 19-503(c) and 19-606(a), the Administrative Office of the Courts or the Client Protection Fund gave notice to each listed attorney that the Supreme Court would issue an Order prohibiting them from the further practice of law in the State of Maryland unless they could show cause why the Court should not take that action. As to the listed attorneys, no sufficient cause has been shown. Accordingly, it is this 3rd day of April 2026, by the Supreme Court of Maryland,

ORDERED that, pursuant to Maryland Rules 19-409(c)(5)(D) and 19-503(c)(4), the attorneys designated in the attached list as being in default of either Rule 19-409 (duty to file IOLTA Report) or Rule 19-503 (duty to file a pro bono legal service report) are decertified and prohibited from practicing law in the State of Maryland; and it is further

ORDERED that, pursuant to Maryland Rule 19-606(b)(2), the attorneys designated in the attached list as being in default of Rule 19-605 (duty to pay annual assessment and to provide SSN

or TIN) are temporarily suspended and prohibited from practicing law in the State of Maryland; and it is further

ORDERED that the clerk of this Court shall provide notice of this suspension and decertification order in accordance with Rule 19-761(b) and post a copy of this Order on the Court's webpage.
