# O R D E R

ORDERED that the petition is granted; and it is further

ORDERED that the cross-petition for writ of certiorari is granted as to the cross-

petitioners' second, third, and fourth questions only;<sup>1</sup> and it is further

ORDERED that a writ of certiorari shall issue to the Appellate Court of Maryland; and it is further

ORDERED that this case is transferred to the regular docket as No. 11, September Term, 2025 (SCM-REG-0011-2025); and it is further

ORDERED that, pursuant to Rule 8-111(a) (the party first appealing the decision of the trial court is designated as the appellant), the Mayor and City Council of Baltimore, Anne Arundel County, and the City of Annapolis are designated as the appellants/cross-appellees and BP, P.L.C., et al. are designated as the appellees/cross-appellants; and it is further

ORDERED that the appellants'<sup>2</sup> brief and record extract shall be filed on or before July 3, 2025. The appellees/cross-appellants' brief shall be filed on or before July 3, 2025. The cross-appellees' brief shall be filed on or before August 4, 2025. The parties' briefs and the record extract shall be filed through the MDEC system in accordance with Maryland Rules 8-501, 8-502, 20-403, 20-404, and 20-406<sup>3</sup>; and it is further
