# STATEMENT RE COURT OF SPECIAL APPEALS POLICY CONCERNING CITATION OF UNREPORTED OPINIONS OF COURTS OTHER THAN MARYLAND STATE COURTS

Maryland Rule 1-104 prohibits the citation of "[a]n unreported opinion of the Court of Appeals or Court of Special Appeals" as either "stare decisis []or persuasive authority." No rule prohibits the citation to or by the Court of Special Appeals of unreported decisions of other federal or state courts as persuasive authority. However, in reported opinions, the Court of Special Appeals has stated that "it is the policy of this Court in its opinions not to cite for persuasive value any unreported federal or state court opinion." *Kendall v. Howard County*, 204 Md. App. 440, 445 (2012), *aff'd* 431 Md. 590 (2013); *see also Poe v. IESI MD Corp.*, 243 Md. App. 243, 256 (2019); *Olivieira v. Sugarman*, 226 Md. App. 524, 553 (2016), *aff'd*, 451 Md. 208 (2017); *Margolis v. Sandy Spring Bank*, 221 Md. App. 703, 718 (2015). The Court of Appeals has not followed a similar policy. *See, e.g., Gables Constr., Inc. v. Red Coats, Inc.*, 468 Md. 632, 663 (2020) (agreeing with an unreported decision of the United States District Court for the District of Maryland); *Finci v. Am. Cas. Co. of Reading, Pennsylvania*, 323 Md. 358, 375-76 (1991) (citing as support "recent unreported decisions" of federal district courts that "have rejected FDIC's public policy contention").

In two reported opinions issued on September 7, 2021, the Court of Special Appeals announced that it is no longer the Court's policy to prohibit the citation of unreported opinions of federal courts or the courts of other states for persuasive value, provided that the jurisdiction that issued any particular opinion would permit it to be cited for that purpose. *See CX Reinsurance Company Limited, et al. v. Devon Johnson, et al.*, No. 691, Sept. Term 2020, slip op. at 20 n.6 (Md. Ct. Spec. App. Sept. 7, 2021); *Gambrill v. Board of Education of Dorchester County, et al.*, No. 0886, Sept. Term 2019, slip op. at 9 n.6 (Md. Ct. Spec. App. Sept. 7, 2021). The attached appendix contains a list of jurisdictions that the Court understands currently permit citation of unreported opinions for persuasive value.

As a caution, this change in policy does not apply to unreported opinions of the Court of Appeals or Court of Special Appeals, which are governed by Maryland Rule 1-104.
