## Substance Abuse Disorder Assessments Ordered, HG-8-505 Calendar Year 2024

Between Circuit and District Court locations, there were 1,215 substance abuse disorder assessments ordered in calendar year 2024. Please see breakdown by county below (Table 1).

As in previous years, CY 2024 8-505 order data collection reflects efforts to increase the accuracy of counting orders through the identification and elimination of multiple evaluation codes used by certain courts. As of May 6, 2024, Baltimore City became the final jurisdiction to complete the transfer of its case management information and data to the Maryland Electronic Courts (MDEC) system.

The Maryland Judiciary continues to train and educate clerks about use of these codes. In May 2024, court order forms for in-patient, out-patient, and in-custody evaluations were updated to specify the appropriate codes for clerk data entry.

When comparing data from calendar year (CY) 2024 (Table 1) to CY 2023 (Table 2), the total number of orders for evaluation increased by 4.3% across both the Circuit and District Courts. Specifically, the number of circuit court orders was relatively flat (a less than 1% increase), whereas District Court orders increased by 26.2% over CY 2023.

*MDEC (Circuit & District Court)* – MDEC "Event Listing" report was run for CY 2024 to identify the frequency of codes indicating the court order or receipt of in-patient, out-patient, and in-custody assessments.

**Baltimore City (Circuit & District Court)** – Baltimore City converted to MDEC in May, 2024. An MDEC "Event Listing" report was run for Baltimore City Circuit and District Courts for assessment orders signed throughout the Calendar Year. Although the number of assessment orders is comparable to those seen in previous § 8-505 legislative reports, the current counts may reflect slight variations due to differences in data coding and conversion from the legacy system.
