

## NOTICE OF REVISION Effective 10/01/2017

The Chief Judge of the District Court of Maryland has revised the following District Court of Maryland Administrative Regulation:

## XVII. DISTRICT COURT PRE-SET FINES AND OR PENALTY DEPOSITS

The attached schedule of preset fines and/or penalty deposits is to be effective for those individuals charged with a violation of the Transportation Article who are desirous of waiving their right to trial and pleading guilty to the offense charged, by payment of the appropriate fine. Where in the schedule the letters "MA" appear opposite a particular offense, the individual charged with that offense is not entitled to prepay a fine, but is required to stand trial.
