

# Online New Employee Orientation

## New Procedure

In January 2019, the Judiciary Human Resources launched the Online New Employee Orientation. The Orientation was developed in conjunction with the Judicial College of Maryland, Department of Professional Development, and is available in the Judiciary's Learning Management System, Canvas.

All new employees will complete registration in CONNECT within the first five business days. When registering it is important to select the orientation start date which corresponds with the employee's start date.

Online New Employee Orientation must be completed within 60 business days from the start date.

## Step 1: Registration in CONNECT

1. Log into CONNECT and click on the **Learning Dashboard** tab.
2. Under **Quick Links**, click on **Find Learning**.
3. In the search bar, type **New Employee Orientation**, then click **Go**.
4. Click **Enroll** for the orientation start date that matches your start date with the Maryland Judiciary.

\*Enrollment is only complete when approved by the supervisor/manager.

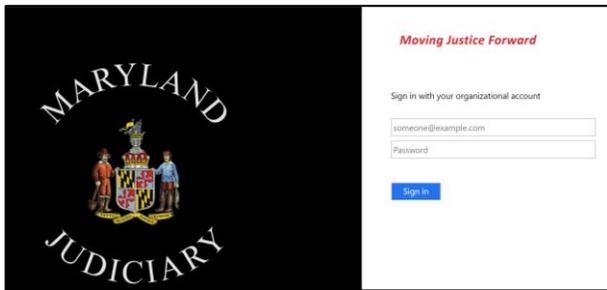

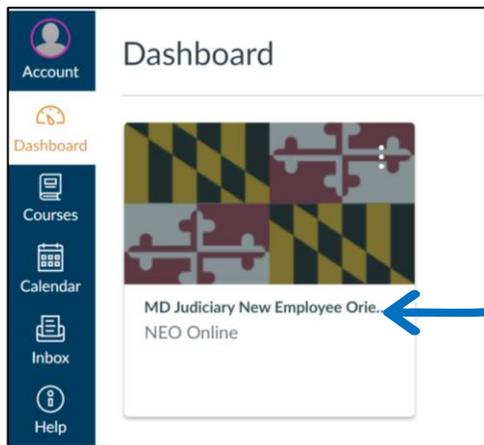
