HERE'S NEWS YOU CAN USE



JUDICIARY EMAIL ADDRESSES (recalled.judge@mdcourts.gov)

In a continuing effort to unify communication services, all recalled judges without a Judiciary email account will be assigned an <u>mdcourts.gov</u> email address. If you are currently on the recalled judge list and do not have an existing <u>mdcourts.gov</u> email address, please contact JIS Help Desk to obtain your email address and login and password information. Once your <u>mdcourts.gov</u> email address is activated, you will no longer be able to receive court related e-mail to your personal e-mail address. Recalled judges with existing <u>mdcourts.gov</u> email addresses, will use their existing login and password credentials which will continue unchanged.

ELECTRONIC TIMESHEETS AND PAYROLL INFORMATION ("CONNECT")

In January 2016, Human Resources is scheduled to implement a new electronic system called CONNECT. Once CONNECT is implemented, all time sheets, including those for recalled judges must be submitted electronically. You no longer will need to carry around a paper time sheet, trying to obtain signatures. With <u>CONNECT</u>, the information will be entered electronically and the system will route it to the appropriate individual at the court where you sat for approval. CONNECT also can be used to submit changes to your address, telephone number, email address, and emergency contact information. CONNECT will not yet be able to electronically receive information regarding your W4, retirement, beneficiary, or benefits. As such, any changes to that information will continue to be processed as it is now. The Judiciary Human Resources staff is ready and willing to assist you.

In the future, you will be able to use CONNECT to register for, and track, your Judicial Institute programs.

A number of training sessions are being planned to assist you in navigating <u>CONNECT</u>. In addition, online training will be available. You will be contacted and advised of the sessions designed especially for recalled judges.

You will be able to access CONNECT through any web browser (i.e., Google Chrome, Safari, Firefox, etc.).

COMPUTER-BASED COMMUNICATION AND DOCUMENT SHARING ("SHAREPOINT")

A <u>SharePoint</u> page has been created for the Retired/Recalled Judges. <u>SharePoint</u> is a web page that allows users to share documents, libraries, announcements and participate in online discussions. If you use <u>SharePoint</u>, you will receive email alerts whenever there are changes or updates to the site. The minutes of the Retired and Recalled Judges Committee will be posted on its <u>SharePoint</u> site. We are in the process of adding other helpful information.

If you are interested in gaining access to the <u>SharePoint</u> site, please contact Sharon Wright at <u>sharon.wright@mdcourts.gov</u> or (410) 260-3451. JIS will ensure you have an active account and will provide instructions on how to access <u>SharePoint</u>. Once you access the site, it would be a good idea either to bookmark the site or add it to your Favorites list so that you won't have to enter the webpage address every time you want to view the site. Ms. Wright will provide instructions on how to accomplish that task. Visit the site often to keep abreast of what's happening that affects retired and recalled judges.

The same active directory account you will be given to access <u>SharePoint</u> can be used to access CONNECT.

ELECTRONIC FILING ("MDEC")

Maryland Electronic Courts, commonly referred to as "MDEC," is Maryland's statewide case management system that when fully implemented will replace the paper filing system in the appellate and trial courts. The courts will have electronic case records instead of paper records.

In October 2014, MDEC was implemented in both trial courts in Anne Arundel County for civil, juvenile, and family cases. Criminal and traffic cases recently were added in August 2015. Attorneys filing cases in Anne Arundel County are required to electronically file. This includes the district and circuit courts, and it includes appeals in the Court of Appeals and Court of Special Appeals from cases originating in Anne Arundel County.

MDEC will be implemented in the Upper Eastern Shore in late winter/early spring 2016, followed by the Lower Eastern Shore by the end of 2016. If you serve as a recalled judge in Anne Arundel County or any of the counties on the Eastern Shore, you should contact Carla Jones at <u>Carla.jones@mdcourts.gov</u> or (410) 260-3526 to inquire about the dates and locations of the upcoming MDEC training sessions for judges. Keep in mind, the official record in all MDEC counties is electronic, so the manner in which cases will be processed in those jurisdictions will be different. Let's get trained so that we are prepared!

EARNINGS LIMIT UPDATE:

In years past, you would receive a year-end wrap up memo detailing how to handle your service dates at the end of the year. We are pleased to inform you that our Internal Affairs Department reviewed the statute and supporting materials pertaining to recall service and has authorized a procedural revision for processing year-end service dates.

- The last pay period of 2015 ends on 12/22/15.
- The first day of the 2016 accounting year is 12/23/15.
- If you have not reached/will not reach your 2015 Earnings Limit by 12/22/15, those days will be paid and tallied with the 2015 pay year.
- If you have reached/will reach your 2015 earnings limit before 12/22/15, any days submitted up through 12/22/15 will be unpaid.
- Service dates between 12/23/15 and 12/31/15 begin the 2016 Earnings Limit tally and everyone may submit for paid service.
