

**11/10/21–11/23/21.** Timesheets will be due for approval by noon on Monday, November  $21^{st}$  and managers must have the approvals completed by 6:00 p.m.

**12/08/21–12/21/21.** Timesheets will be due for approval by noon on Monday, December 20<sup>th</sup> and managers must have the approvals completed by 6:00 p.m. This will be the last pay period paid in 2021. **The 2022 Earnings Limitation will begin on December 22, 2021**.
