Maryland's network of Court Law Libraries serves the needs of Maryland's citizens, courts, attorneys, and government by building and preserving collections of legal information resources, promoting access to these collections, and creating educational opportunities that enhance the understanding of legal information.

Since its founding in 2008, the Conference of Maryland Court Law Library Directors has provided a forum for policy discussion, information exchange, and professional development for the state's court law library community. The Conference supports the mission of the Maryland Judiciary by providing advice and support to all Judiciary bodies in matters affecting court law libraries. Conference support addresses court law library standards, retention and disposal of court library resources, court library funding, service to the public, and access to justice through education and the provision of legal information.

Conference Projects

Frontlines Project

The Conference partners with the State Law Library, the Maryland Access to Justice Commission, and the Maryland Judiciary's Access to Justice Department, to provide training to public library staff in the provision of legal reference. The project, *Law on the Frontlines: Legal Reference for Public Libraries* (aka Frontlines Project), began in 2016. In FY2025, its eighth year of training classes, 155 project participants were provided six webinars, including special topic sessions on *Legal Forms* and *Landlord and Tenant*.

Promotion of Court Law Libraries: Marketing/Outreach Inside/Outside the Law Library

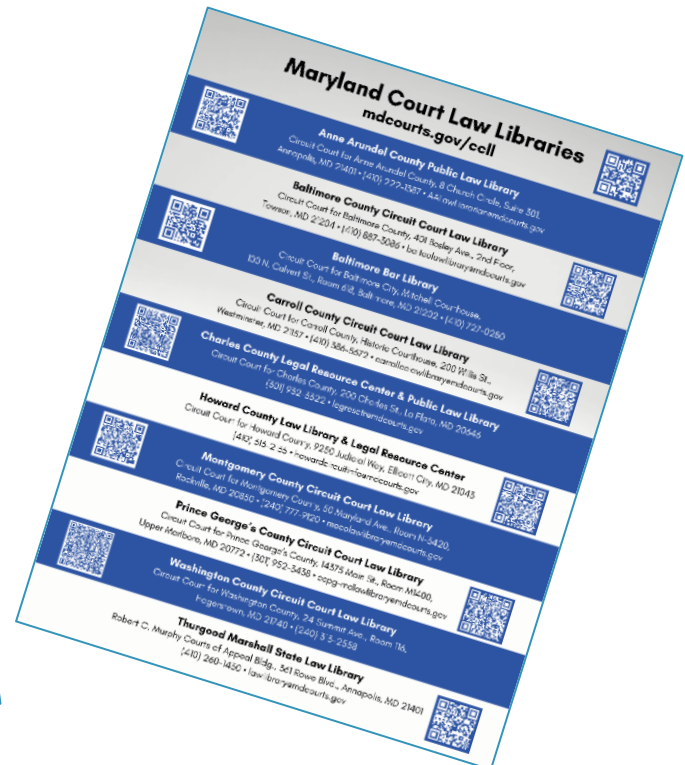
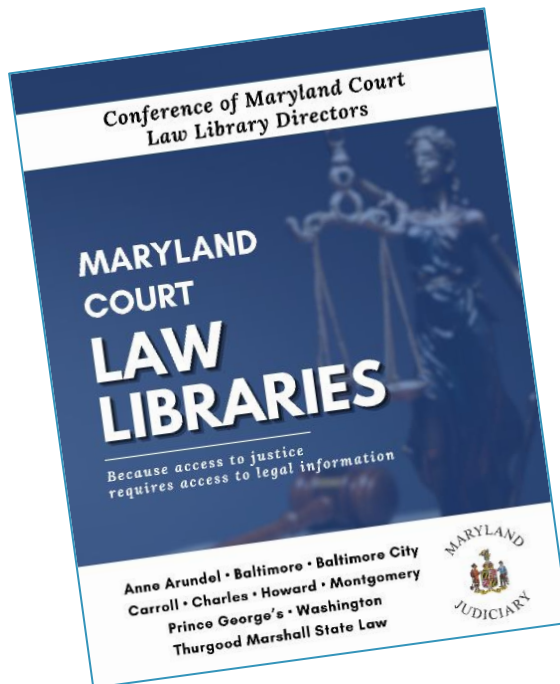
This committee of the whole was created to consider promotion ideas. CMCLLD members promoted court law libraries by:

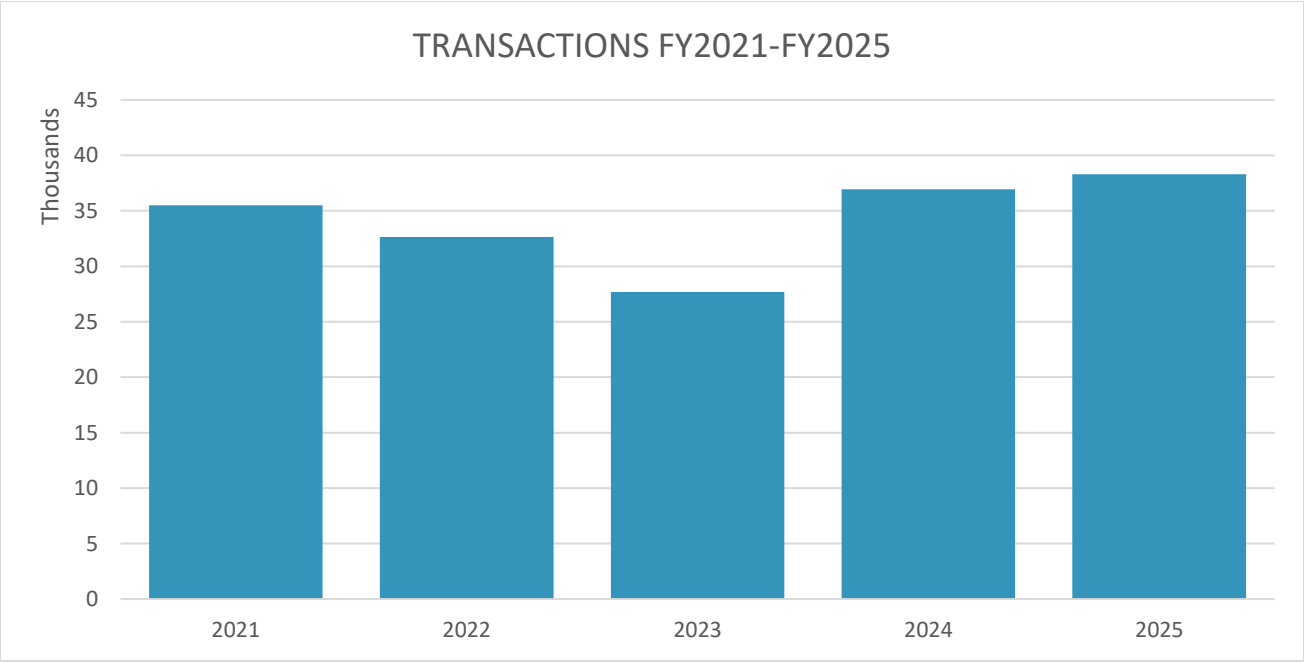
Conference Statistics

Conference libraries collect statistics in a standardized manner to demonstrate workload across the state. Maryland’s court law libraries assist the Judiciary, law practitioners, and the public. Assistance includes traditional legal reference and research guidance, referrals to legal assistance and social service organizations, technology navigation support, and more. Several law libraries are co- located with the local Help Center or Family Law Clinic (Anne Arundel, Baltimore, Charles, Howard, and Washington counties).

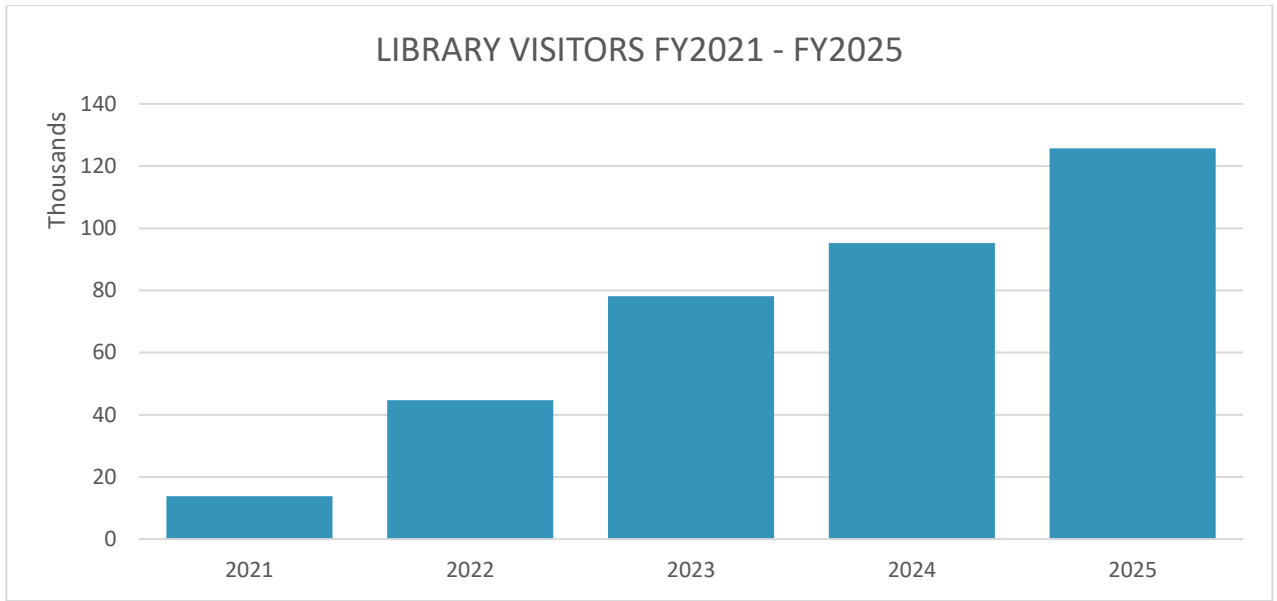
In fiscal year 2025, Maryland court law libraries provided more than 38,000 instances of service. It should be noted that Maryland Court libraries, with the exception of the Thurgood Marshall State Law Library, provide these services with a small staff of three or less, some with only one librarian on staff.

The number of law library transactions remained steady with a slight increase of 3.6%.

Use statistics do not include numbers from Baltimore County starting in FY2022. There are no statistics for Baltimore City.



Court law library visits rose from 95,283 in FY2024 to 125,733 in FY2025, representing a 32% increase.

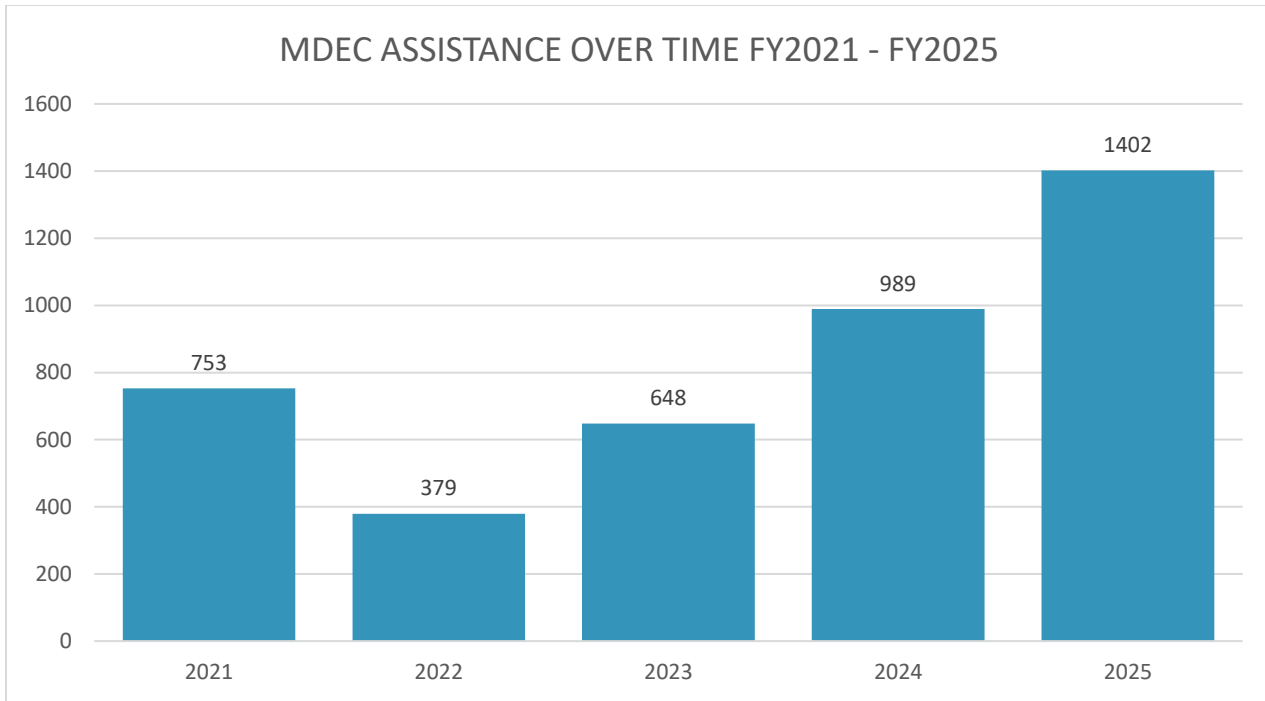

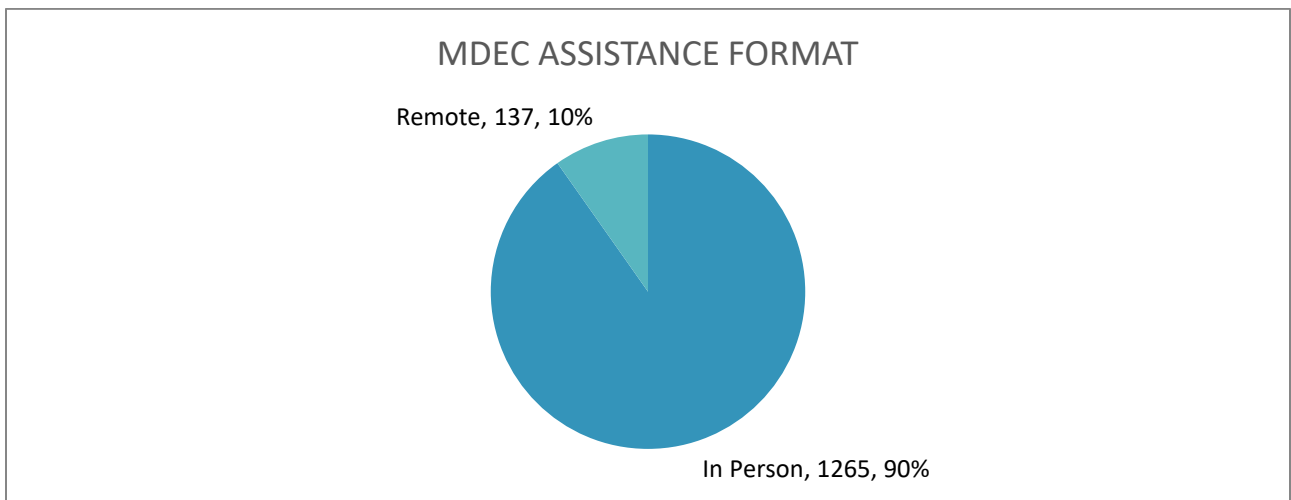
MDEC Assistance

Law libraries provide support for court e-filing. All Conference libraries have MDEC kiosks on site for the use of attorneys and the public to view and print case filings. Conference libraries also have public computer stations that can be used for e-filing. Library staff assist with e-filing and the access and use of the MDEC kiosks.

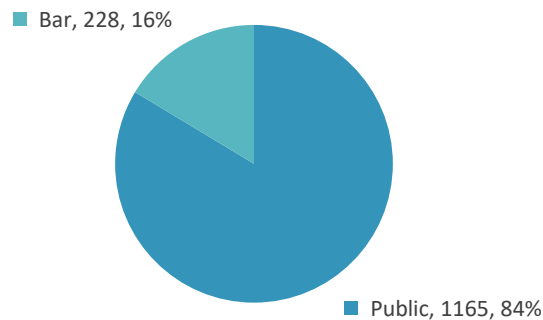
With the adoption of MDEC, law library staff have increasingly assisted the bar and public with performing electronic filings and accessing electronic case documents. All law libraries contain computers with MDEC File and Serve and Public Kiosk portals. Law library staff are trained to assist attorneys and the public with basic MDEC needs.



In fiscal year 2025, library staff assisted library patrons with 1402 instances of MDEC-related assistance, a 41% increase over the previous fiscal year. Most instances of service involved assisting non-attorneys in-person.

Maryland Court Law Library Highlights

The Legal Resource Coordinator's office in **Charles County** Circuit Court Law Library & Legal Resource Center was remodeled.

The **Anne Arundel County Public Law Library** rearranged their FCHC area to accommodate an additional FCHC staff member. A desk for the administrative assistant was placed where people entering the law library could easily see. Signs were hung in the area indicating center location and the sign-in table computer. The placement of the signs and staff desk make the Center location more apparent upon entering the library

LEGAL REFERENCE

Law library staff use their expertise to connect the Judiciary, attorneys, and the public with legal information. This information includes web-based informational resources, such as the People's Law Library; legal database access; digital materials; and traditional print materials. Library staff guide patrons to the materials that work best for their legal research needs and level of comfort with legal materials.

Law libraries provide equitable access to materials unavailable elsewhere to the public and small/solo legal practitioners due to paywalls or subscription fees. These resources include databases like Westlaw, LexisNexis, HeinOnline, PACER, and SASI-CALC, as well as extensive legal treatises and sample form books, annotated laws, and more. This also includes legal texts for non-lawyers, such as Nolo Press publications. These resources provide the public with valuable information on unique subject areas, including family law, business law, traffic, wills, trusts, and estates.

In fiscal year 2025, law librarians continue to enhance their legal resource collections in various ways.

The **Charles County Circuit Court Legal Resource Center & Public Law Library** reviewed the current library collection and surveyed the local bar association to determine if there are resources that should be considered for addition to the collection and are working on a full collection review.

Prince George's County Circuit Court Law Library contributes to the Court Newsletter with library book reviews.

The **Anne Arundel County Public Law Library** created an online index of print forms available on "the wall" for FCHC staff and clients in chart form showing form name, its link and shelf location.

The Baltimore County Local Rules at the **Baltimore County Access to Justice Resource Center** have been updated and can be accessed through the library catalog.

The **Maryland Thurgood Marshall State Law Library** completed a full inventory of Maryland House/Senate Journals in FY25 and reorganized them for enhanced access and continued to perform a collection review in preparation for a future building move.

The **Carroll County Circuit Court Law Library** requested a link be added to their Court's web page for access to their Court's archived Administrative Orders.

The collection of the **Howard County Law Library & Legal Resource Center** is being reviewed for deeper development, to remove obsolete materials and ensure materials can be located in the appropriate identified area.

The **Montgomery County Circuit Court Law Library** improved navigability by creating and placing multiple library map posters around the library and increased directional signage in the stacks and improved the Education/School Law collection by weeding and adding new titles.

LEGAL REFERRALS

- When litigants need legal advice, law library staff make informed referrals to court programs and services, including all Maryland Court Help Centers. When litigants need assistance that goes beyond legal advice law library staff make referrals to appropriate legal service providers, community services and government agencies. In fiscal year 2025, law library staff provided 2350 legal referrals to over 20 organizations including but not limited to:

GUIDES AND EDUCATIONAL PROGRAMS

Law Librarians craft guides that provide information to help attorneys and self-represented litigants navigate their libraries and courthouses and provide educational/training programs.

The **Prince George's County Circuit Court Law Library** created [Guides and/or Pathfinders](#) based on FAQs such as Administrative Actions, Expungement, Foreclosure, to name a few. The Guides can be accessed from the library's webpage. The Guides provide categories such as links to the Md Code, Court Rules, frequently used forms, legal resources and resources in their collection. The library hosted an intern in FY25. The intern contributed significantly to library projects and services while learning marketable workforce skills and developing a professional network.

The **Howard County Law Library & Legal Resources Center** Librarian participated in the Courthouse Lunch and Learn program; organizes and leads courthouse tours for girl scout and boy scout troops when requested.

The **Anne Arundel County Public Law Library** provides FAQ and Family Law Resource handouts that are available online and in the Help Center via QR Code posters.

The **Law Library at the Carroll County Circuit Court** provided a Library Referral Guide to front office staff at the Carroll County Circuit Court Clerk's Office. Business students and their professor from Carroll County's local community college toured the Law Library and learned about its resources. The Librarian provides educational walking tours of the Historic Courthouse to the public upon request.

The **Maryland Thurgood Marshall State Law Library** continues to offer in-house continuing education for library staff. FY2025 included programming on the classic reference interview. Library staff also redesigned and updated the [Maryland Court Law Libraries Directory](#).

The **Charles County Circuit Court Law Library & Legal Resource Center** will offer books that have been pulled from their Law Library collection to the local detention center library.

Montgomery County Circuit Court Law Library provides legal research training to court employees, paralegal students, and high school students. The library gave a 2-hour lesson on the library and basic legal research to local high school students enrolled in Montgomery County Public Schools Summer RISE program at the court and held legal research training and library tours for court employees, paralegal students and high school students. Staff worked with their A2J Coordinator to provide a Lunch and Learn program on general information for court employees.

PARTNERSHIPS

All court law libraries provide access to the Maryland Court Help Center via phone and/or library computers for chat. Multiple law libraries host recurring self-help programs such as legal clinics and Lawyer in the Law Library programs in-person and/or virtually. Some are co-located with court help centers to provide seamless access to legal information and advice.

The **Montgomery County Circuit Court Law Library** partners with the Montgomery County Bar Association by contributing monthly newsletter education articles and they are planning to resume the Everyday Law programming, through Zoom and in-person at the public library, in partnership with local attorneys.

The **Baltimore County Access to Justice Resource Center** makes use of the Language Services but occasionally still uses the Language Line.

The **Howard County Circuit Court Law Library & Legal Resource Center** partners with the Howard County Bar Association to encourage and coordinate the volunteer attorneys who staff the Court's Family Law Assistance Program and the Civil Law Center. The Law Library also partners with the 50+ Center where evening sessions of the Court's Family Law Assistance Program are held. The Law Librarian also manages two free legal advice programs at the Law Library in its conference rooms: the Family Law Assistance Program and the Civil Law Center. Each Program targets low income, self-represented litigants.

The **Prince George's County Circuit Court Law Library** partners with the Prince George's County Bar Association through contributing to the monthly Bar Association Journal to foster community engagement and to offer more comprehensive legal and information resources.

The **Charles County Circuit Court Legal Resource Center and Public Law Library** offers two free legal advice programs: the Family Law Assistance Program and the Civil Law Center.

The **Law Library at the Carroll County Circuit Court** continues to partner with their Family Law Administration on civil docket days in the Historic Courthouse by providing conference rooms, computers/printers, SASI-Calc/Alimony calculators and copier services for same day ADR and mediation of family law cases for self-represented litigants and attorneys.

The Law Librarian at the **Washington County Circuit Court Help Center and Law Library**, working

closely with their community partners, the Gatekeepers of Hagerstown and CASA, attended many meetings in order to discuss ways to assist those who are reintegrating with society or have experienced domestic violence. In addition, as a result of an increase in expungement questions, they are preparing to partner with Maryland Legal Aid to offer expungement clinics four times a year.

The **Anne Arundel County Public Law Library** helped with the coordination of brief legal advice clinics held at the Chrysalis House, provided research assistance to high school STEM students researching legal pro bono services, served on the Court Bring Your Child to Work Committee and continues to coordinate the weekly, remote Lawyer in the Library program with the Anne Arundel County Public Library through partnership with the Maryland Volunteer Lawyers Association (MVLS) and the Anne Arundel Bar Association. The Law Librarian is a member of the Anne Arundel Local Pro Bono Committee.

The **Maryland Thurgood Marshall State Law Library** regularly collaborates with the Maryland State Archives and the Department of Legislative Services to discuss their shared goals for long-term access to Maryland government materials. The library also collaborates with the Maryland State Archives regarding ongoing conservation efforts with their Special Collections materials.

TECHNOLOGY ASSISTANCE

In addition to assisting with legal research, law libraries use technology to connect people to legal information and provide technical assistance to those who need it. Law library staff provide technical assistance in-person as well as remotely via phone, email, and Zoom. Technical assistance includes helping litigants navigate websites and legal databases, using child support calculators, uploading and downloading documents, scanning and printing documents, and operating microfilm and microfiche readers.

Charles County Circuit Court Legal Resource Center and Public Law Library introduced a kiosk named Charley to assist with check-ins and help visitors locate their cases on the docket. Charley is programmed in both Spanish and English and features an interactive map to guide visitors to their destinations. She is currently undergoing testing to enable her to respond to questions using AI technology.

Montgomery County Circuit Court Law Library revised their library services webpage.

The **Anne Arundel County Public Law Library** created an online index of print forms available on “the wall” for FCHC staff and clients using Teams and shared with the FCHC. The index is in chart form showing form name, its link and its shelf location. Attorneys and the public continue to make use to the small conference room for videoconferencing hearings and phone for MCHC access. As a member of the Anne Arundel Local Pro Bono Committee, the law librarian maintains the online space for the Committee.

The **Prince George’s County Circuit Court Law Library** provides dedicated access to Zoom for patrons including Self-Represented Litigants, attorneys and Court interpreters who do not have access to the Internet or a compatible electronic device for court hearings.

Baltimore County Access to Justice Resource Center now has one AJRC website after a consolidation was performed, and more titles will be available through Westlaw only as the library will have more online access.

The **Washington County Circuit Court Help Center and Law Library** is equipped with digital reference resources to serve the public with accurate and up-to-date legal information.

The **Howard County Circuit Court Law Library Legal Research Center** offers videoconferencing on one computer to provide video access to the Maryland Court Help Center and added two more public access computers and scanners.

The **Carroll County Circuit Court Law Library** continues to offer a dedicated Self-Help Computer center for Self-Represented Litigants and began exploring the possibility of enhancing their legal reference resources by adding a Digital eBook service to their collection to improve access to its collection.

Maryland Thurgood Marshall State Law Library expanded efforts to preserve and digitize legal resources. The library continued archiving key government web pages and sent 500 reels of The Daily Record (1929-2022) to the Maryland State Archives for digitization. The library also remains active in the Legal Information Archive, a consortium with Georgetown & Harvard Universities as well as Virginia and Washington State law libraries. In FY25 the library implemented its new public catalog platform, Aspen Discovery, which provides users with a modern, mobile-responsive interface.

Awards, Recognition and Member Accomplishments

Audrey Dingler and Joy Hollerbach of the Thurgood Marshall State Law Library presented a program, *“Keeping It Current: Updating Your Library’s Legal Reference Guide,”* at the Maryland Library Association/Delaware Library Association (MLA/DLA) Conference in May 2025.

Joan Bellistri participated in the panel, *“Putting Law Libraries on the Map – Using GIS Technology to Promote Services to the SRL,”* at the SRLN Conference in September 2024.

Joan Bellistri and Julia Viets participated in the panel, *“Put It on the Map: Using GIS Technology to Answer Questions About Our Communities,”* at the Maryland Partners for Justice Conference in May 2025.

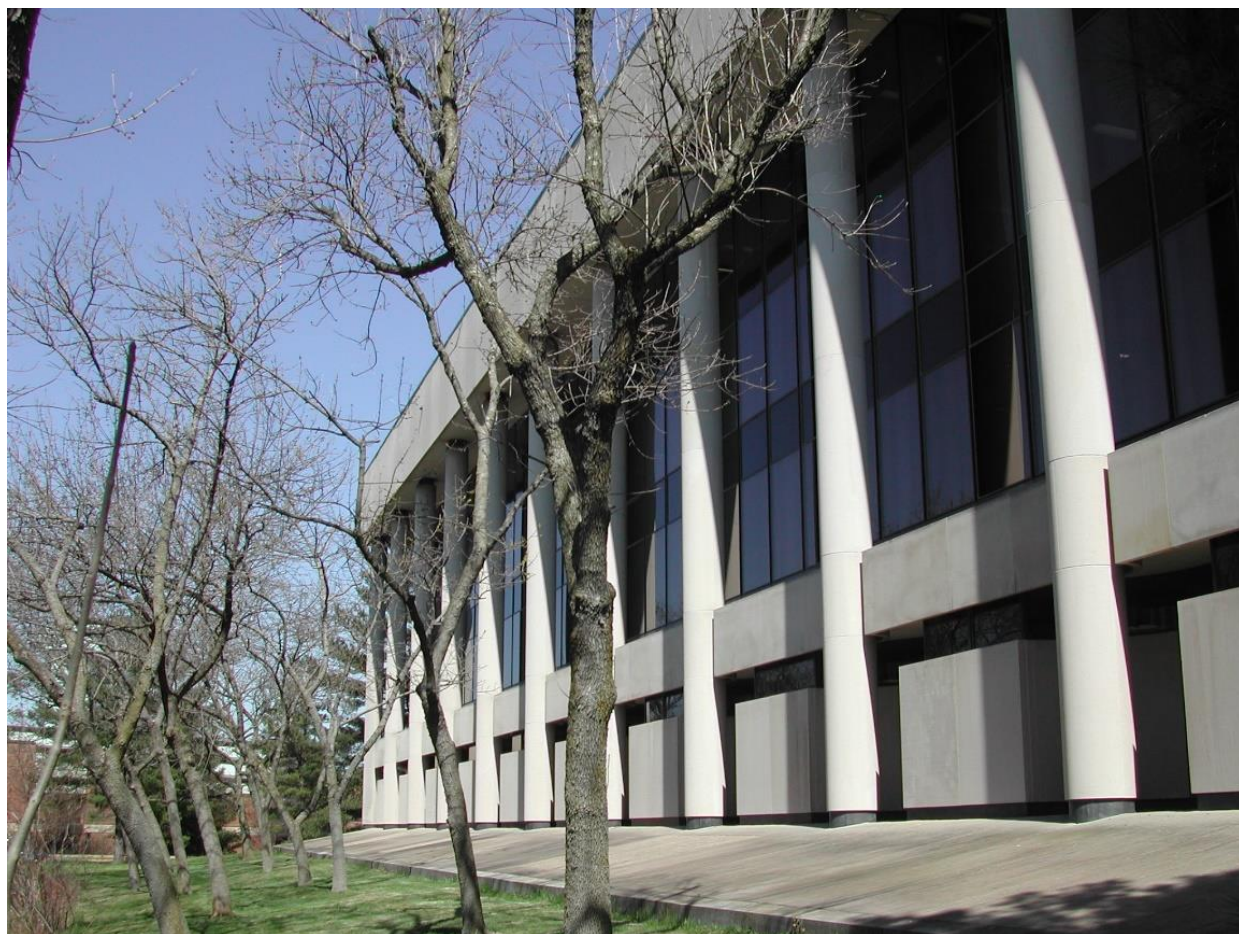


FIGURE 8 THURGOOD MARSHALL STATE LAW LIBRARY
