#### Conflict Resolution Project Grants

MACRO's Conflict Resolution Projects Grant Program provides funding for Alternative Dispute Resolution (ADR) programs or projects which support and further its mission to develop, improve, and expand high quality alternative dispute resolution (ADR) services in Maryland's courts, communities, criminal and juvenile justice programs, state and local government agencies, as well as schools and universities for the benefit of the general public.

#### Grant Purpose

These grants are being offered to benefit the courts and people of Maryland with the goal of increasing efficiency in the courts, expanding access to justice, and preventing conflicts from escalating into violence or litigation.

Categories for funding consideration:

- **Starting or Expanding an ADR Program**
- **Mediator/ADR Practitioner Quality**
- **Public Conflict Resolution Education**
- **Conflict Resolution Services**
- **ADR-related Research**

Activities MACRO will not fund:

MACRO will not fund religious, political, or lobbying activities.

#### Eligible Applicants

**Courts and local government agencies, non-profits, institutions of higher education**

#### Availability and Awards of Funds

The availability of funds is contingent upon the provision of funds in the Maryland Judiciary budget by the Maryland General Assembly for Fiscal Year 2019. Applicants who are awarded funding will receive notice in early June of 2018.
